

Statement of Rights and Responsibilities

This Statement of Rights and Responsibilities governs our relationship with users and others who interact with the Great American Teachers' Club. By using or accessing the Great American Teachers' Club, you agree to these terms of service.

1. Privacy Policy / Refund

We strictly protect the security of your personal information and honor your choice for its intended use. We carefully protect your data from loss, misuse, unauthorized access or disclosure, alteration, or destruction, and will not distribute personal information to third parties.

We respect your rights and value you as a consumer. Due to this, we offer a full money back guarantee on any merchandise purchased from us.

2. Sharing Your Content and Information

You own all of the content and information you post on the Great American Teachers' Club.

In addition:

1. For content that is covered by intellectual property rights, like photos and videos ("IP content"), you specifically give us the following permission, subject to your privacy and statement of rights and responsibilities: you grant us a non-exclusive, transferable, sub-licensable, royalty-free, worldwide license to use any IP content that you post on or in connection with Great American Teachers' Club ("IP License"). This IP License ends when you delete your IP content or your account unless your content has been shared with others, and they have not deleted it.
2. When you delete IP content, it is deleted in a manner similar to emptying the recycle bin on a computer. However, you understand that removed content may persist in backup copies for a reasonable period of time (but will not be available to others).
3. We always appreciate your feedback or other suggestions about Great American Teachers' Club, but you understand that we may use them without any obligation to compensate you for them (just as you have no obligation to offer them).

3. Safety

We do our best to keep Great American Teachers' Club safe, but we cannot guarantee it. We need your help to do that, which includes the following commitments:

1. You will not send or otherwise post unauthorized commercial communications (such as spam) on Great American Teachers' Club.
 2. You will not collect users' content or information, or otherwise access Great American Teachers' Club, using automated means (such as harvesting bots, robots, spiders, or scrapers) without our permission.

4. **Registration and Account Security**

 6. You will not post anyone's identification documents or sensitive financial information on Great American Teachers' Club.

7. **Amendments**

 2. For changes to sections 7, 8, 9, and 11 (sections relating to payments, application developers, website operators, and advertisers), we will give you a minimum of three days notice. For all other changes we will give you a minimum of seven days notice. All such comments must be sent via email to admin@greatamericanteachersclub.com.
 3. We can make changes for legal or administrative reasons upon notice without opportunity to comment.
8. **Termination**

If you violate the letter or spirit of this Statement, or otherwise create possible legal exposure for us, we can stop providing all or part of Great American Teachers' Club to you. We will notify you by email or at the next time you attempt to access your account. You may also delete your account or disable your application at any time. In all such cases, this Statement shall terminate, but the following provisions will still apply: 2.2, 3-5, 9.1-9.3, 11.2, 11.5, and 11.6.

9. Disputes

1. You will resolve any claim, cause of action or dispute ("claim") you have with us arising out of or relating to this Statement or Great American Teachers' Club exclusively in a state or federal court located in Fulton County. The laws of the State of Georgia will govern this Statement, as well as any claim that might arise between you and us, without regard to conflict of law provisions. You agree to submit to the personal jurisdiction of the courts located in Fulton County, Georgia for the purpose of litigating all such claims.
2. If anyone brings a claim against us related to your actions, content or information on Great American Teachers' Club, you will indemnify and hold us harmless from and against all damages, losses, and expenses of any kind (including reasonable legal fees and costs) related to such claim.

WE WILL NOT BE LIABLE TO YOU FOR ANY LOST PROFITS OR OTHER CONSEQUENTIAL, SPECIAL, INDIRECT, OR INCIDENTAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH THIS STATEMENT OR GREAT AMERICAN TEACHERS' CLUB, EVEN IF WE HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. OUR AGGREGATE LIABILITY ARISING OUT OF THIS STATEMENT OR GREAT AMERICAN TEACHERS' CLUB WILL NOT EXCEED THE GREATER OF ONE HUNDRED DOLLARS (\$100) OR THE AMOUNT YOU HAVE PAID US IN

6. By "post" we mean post on Great American Teachers' Club or otherwise make available to us (such as by using an application).
7. By "use" we mean use, copy, publicly perform or display, distribute, modify, translate, and create derivative works of.
8. By "active registered user" we mean a user who has logged into Great American Teachers' Club at least once and who's membership is financially up-to-date.
